

The Blues Foundation's Generation Blues Education Grant FY 2023

The Blues Foundation (TBF) is committed to working in partnership with qualified Affiliates to expand appreciation of blues music and its history by providing structured educational programming to young people. TBF will offer a limited number of competitive Generation Blues Education Grants to Affiliate organizations whose multi-disciplinary, experiential blues education programs <u>present the historical context of early blues music</u>, underscore the contemporary relevance of the blues, stimulate intellectual advancement, and encourage cultural understanding.

Eligible organizations <u>must be 501c3 tax exempt</u> and have current membership with The Blues Foundation.

Successful applicants will meet all or most of the following criteria:

- Identifies educational programming as a primary objective in the Affiliate's strategic plan
- Has a confirmed partnership with a school, community center, or grassroots organization
- Has a written education plan that includes clear educational objectives and outcomes that align with Common Core Standards or an established school curriculum
- Employs trained teaching artists
- Engages underserved populations (defined as communities of color, low-moderate income, rural, urban communities)
- Includes metrics or other measures of success
- Confirmed Child Protection clearances and required background checks
